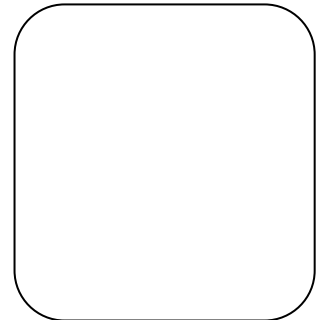

Rules & Regulations

Students are advised to go through the Rules and Regulations before filling the Admission form.

- 1) Students must be regular and punctual in attendance of Classes, Tutorials and submission of term-work on various topics.
- 2) Students may not be allowed to sit in the examination in case of dissatisfactory progress, irregularity, misconduct, short attendance and nonpayment of fee.
- 3) Students are expected to maintain strict discipline within and outside the classroom, workshop, library, laboratories and observe the prescribed time to time.
- 4) Students using Institutional material remain the property of the institute.
- 5) Students shall not handle or displace any of the models, apparatus, and books belonging to the Institute except the permission of the concern person.
- 6) Any students who is persistently insubordinate or repeatedly willfully mischievous or is guilty of malpractices in connection with the examination or has committed an act serious indiscipline or misbehavior or who in the opinion of the institute has an adverse influence on his fellow students, may be expelled permanently or removed from the rolls for a specified period by the Centre Manager/ Director.
- 7) Smoking and chewing Tobacco in the premises is strictly prohibited.
- 8) Once admission is taken no refund will be given to student whatever the cause may be and installments must be paid on 1st of every month otherwise Rs. 10/- per day fine will be levied after 7th of that month. The student will be debarred from classes and/or Lab after 16th. He has to take readmission after paying Rs. 200/- .
- 9) Examination for all the courses is conducted by IICT Delhi Office.
- 10) The institute reserves the right to postpone reschedule the classes due to unforeseen circumstances.
- 11) Students have to appear for mock interview, walk through, project and tests as per schedule.
- 12) Students must compulsorily wear shoes or sandals and decently dressed.
- 13) Refer to the fee structure before filling the course name.
- 14) Students must ensure to pay final Exam fees Rs. 500/- immediately after completion of courses, to be able to sit in the exam.
